a. Green Ribbon of Hope Month

WHEREAS over 56,000 children are reported missing annually in Canada and thousands more are victims of exploitation; and

WHEREAS children and families in Ontario and this community are victims of this tragedy; and

WHEREAS increased awareness of the problem is needed to help reduce the incidence of missing, abducted and exploited children and teenagers, as well as to help locate missing children; and

WHEREAS this is a community issue, not just a family one and a missing child is everyone's responsibility; and

WHEREAS the month of May is set aside to rekindle new hope in the search for all missing children; and

WHEREAS the month of May also supports National Missing Children's Day on each May 25th;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of Essa does hereby proclaim May 25th, 2010 as National Missing Children's Day, and the month of May 2010 as Green Ribbon of Hope Month in the Township of Essa; and

THAT we join Child Find Ontario in urging citizens in Ontario to remain vigilant in our common desire to protect and nurture the youth of Ontario.

b. Physician Appreciation Day

WHEREAS good health is integral to the enjoyment of life; and

WHEREAS physicians help to provide health care within the community; and

WHEREAS the community appreciates the services of its physicians;

NOW THEREFORE BE IT RESOLVED THAT the Township of Essa does hereby proclaim May 31, 2010 as Physician Appreciation Day; and

THAT residents and businesses in the Stevenson Memorial catchment area are encouraged to show their appreciation in ways that will enhance this day of recognition and celebration.

c. Cycling Safety Week

WHEREAS cycling is becoming a popular mode of transportation in our communities, providing daily physical activity and a means of transportation; and

WHEREAS cycling is an environmentally friendly, healthy lifestyle choice; and

WHEREAS as our communities develop to support active transportation, it is imperative that cyclists and drivers of motor vehicles share the road safely, to reduce the frequency, impact and severity of preventable injuries to cyclists on our roadways;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of Essa does hereby designate the week of June 5 – 11, 2010 as Cycling Safety Week –

Share the Road in Essa Township; and further

THAT Council encourages residents to participate in “ride your bike to work/school day” on June 9th and other cycling related activities.

d. Children’s Mental Health Week

WHEREAS one in five kids in Ontario struggles with their mental health; and

WHEREAS ensuring the mental health of our children is essential to their growth and development; and

WHEREAS children and adolescents can suffer various mental health problems, including depression, anxiety, eating disorders, conduct disorder, attention deficit hyperactivity disorder, schizophrenia and bi-polar disorder; and

WHEREAS treatment works. Early interventions are effective, leading to significant improvements in academic process, social development, behavior, and mental well-being; and

WHEREAS many young people who would benefit from mental health services are not receiving the help they need; and

WHEREAS learning to recognize the early warning signs of mental health problems and where to obtain necessary assistance and treatments gives children and youth better opportunities to lead full and productive lives;

*NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of Essa does hereby proclaim the week of May 3 – May 7, 2010 as **Children’s Mental Health Week** and encourages everyone to work together to raise awareness of the mental health needs of the children and youth in our community.*

10. BY-LAWS

a. By-law 2010 – 23

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 - 23, being a by-law to establish and assume for public highway purposes Kallen Boulevard, Plan 51M-688; Vanderpost Crescent, Plan 51M-688; and Davis Trail, Plan 51M-688, in the Township of Essa, County of Simcoe, being all of PINS: 58115-0274 (LT); 58115-0273 (LT); and 58115-0272 (LT); and that said By-law be read a first, and taken as read a second and third time and finally passed.*

b. By-law 2010 –

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 -, being a by-law to establish and assume for public highway purposes Cunningham Drive, Plan 51M-639; Henry Street, Plan 51M-639; Meadowland Boulevard, Plan 51M-639; Evergreen Lane, Plan 51M-639; Block G, Plan 1605; and Block I, Plan 1605; in the Township of Essa, County of Simcoe, being all of PINS: 58116-0300 (LT); 58116-0301 (LT); 58116-0302 (LT); 58116-0303 (LT); 58116-0304 (LT); 58116-0177 (LT) and 58116-0178 (LT); and that said By-law be read a first, and taken as read a second and third time and finally passed.*

c. By-law 2010 –

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 -, being a by-law authorizing the Mayor and Clerk to enter into an agreement with Clauriz Construction Inc. with respect to Part of Lots 31 and 32, Concessions 3 and 4, Township of Essa; and that said By-law be read a first, and taken as read a second and third time and finally passed.*

d. By-law 2010 –

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 -, being a by-law to amend the Township's Zoning By-law, By-Law No. 2003-50, with respect to Lots 3 to 15, Plan 1116, 165 Mill Street, Angus, Township of Essa; and that said By-law be read a first, and taken as read a second and third time and finally passed.*

e. By-law 2010 –

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 -, being a by-law of the Corporation of the Township of Essa to amend By-law 98-10, as amended, and By-law 2003-45, being a By-law to prescribe rates of speed along portions of highways in the Township of Essa; and that said By-law be read a first, and taken as read a second and third time and finally passed.*

f. By-law 2010 –

Recommendation: *Be it resolved that leave be granted to introduce By-law 2010 -, being a by-law authorizing the Mayor and the Clerk to enter into an Agreement with Her Majesty the Queen in Right of Ontario as represented by the Minister of Community Safety and Correctional Services and conjointly the Township of Essa, the Town of New Tecumseth, the Township of Adjala-Tosorontio and the Nottawasaga Police Services Board for the Safer Communities 1,000 Officers Partnership Program; and that said By-law be read a first, and taken as read a second and third time and finally passed.*
