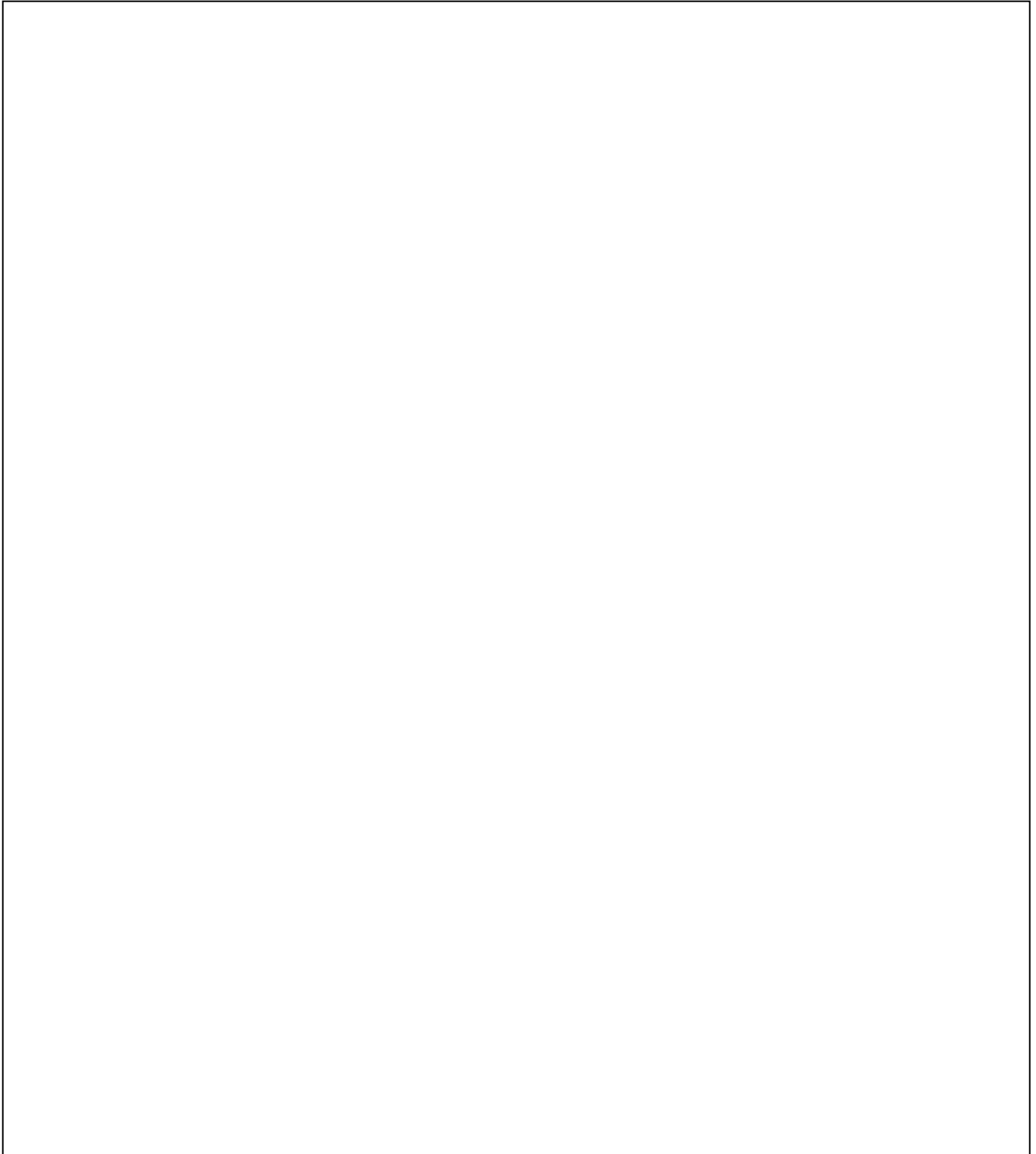

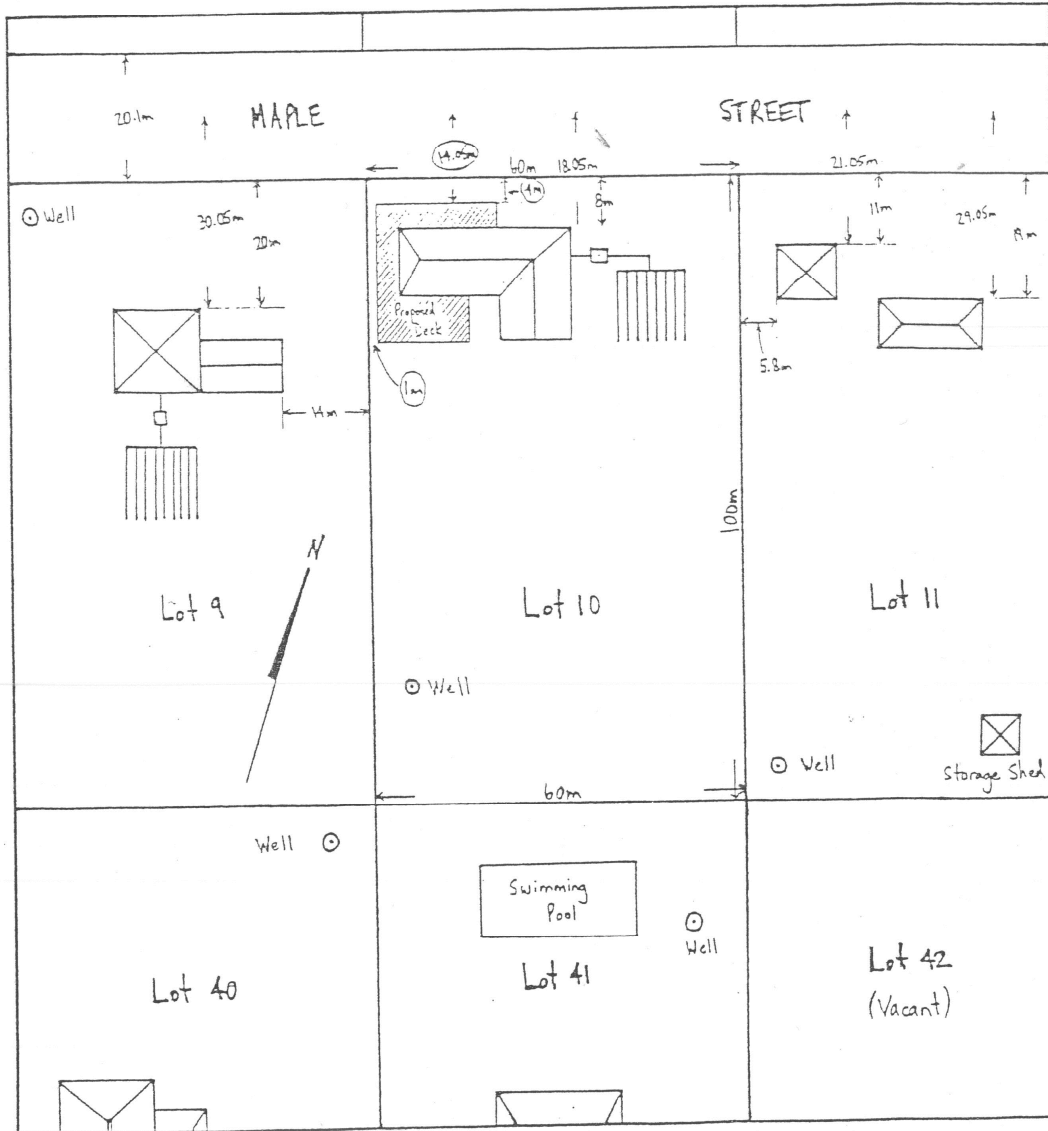
SAMPLE SITE PLAN
