CONDITIONS APPLICABLE TO THIS PERMIT AS FOLLOWS:

- ▶ This permit is not valid at any time from; one half hour after sunset to one half hour before sunrise, or at any other time when, due to insufficient light, unfavourable conditions or persons and vehicles on the highway are not clearly discernable at a distance of 150 metres or less. This permit is issued subject to weather conditions permitting the move(s).
- ▶ This permission is given on the understanding that the applicant is fully responsible for any claims for any accident or damage which may arise against the Corporation of the Township of Essa due to the various equipment occupying Township roads while the move(s) are being made and the Applicant shall have adequate insurance coverage in effect.
- ▶ **During the load restriction period, special permission must be obtained to move loads greater than 5 tonnes per axle on posted Township roads. If the temperature rises above 0 degrees Celsius and thaw conditions are being experienced, this special permission is automatically revoked.**
- ▶ This permit does not apply to roads or structures which have been posted for reduced loads.
- ▶ The Applicant shall particularly take care of all the overhead utility lines and arrange with the appropriate utility for its assistance.
- ▶ The Applicant shall be responsible for all damages caused to the Township road(s) by reason of the driving operating or moving of such wide load(s) and/or heavy vehicle(s).
- ▶ It is the Applicants responsibility to arrange for a Certified Superload Escort if required by the HTA.
- ▶ It is the Applicants responsibility to follow all requirements of the Highway Traffic Act.
