Chairperson's remarks - February 2025

Welcome to our 2nd meeting of 2025, and our last virtual meeting for this winter season. Spring is coming, and this is advanced notice that the March meeting will be held in person at the Thornton branch. I will not be available, so Carol will be chairing the meeting.

Thank you, Laura, for sending the podcast "Library Lobby – Talking to Candidates Who Want your Vote", and the Fifth Estate episode – A Shadow War on Libraries (CBS News). It is very important that we are aware of what is going on in the larger library landscape. I hope everyone had a chance to view or listen to them.

I had seen the Fifth Estate episode when it was originally aired and was very disturbed by the content. I would like to take a moment to review censorship in the public library. In short – with the exception of something illegal such as pornography, there is no room for library or political censorship other than for the parent's right to decide what is suitable for their own children to read, view, or participate in. It is the Public Library's duty to offer a wide variety of information and allow those who use the library the ability to choose what they wish to access.

Canadian libraries don't exist to coerce anyone's beliefs or commitments. However, varying opinions about what should or should not be available in Canada's publicly funded libraries surfaced as a constant topic in the Canadian media in 2024. (Article by FOPL)

Ontario's <u>Public Libraries Act</u> (PLA) is the key piece of legislation governing Ontario's public libraries. It supports the provision of equal and universal access to information and establishes free public library services in Ontario through governance and regulations.

Overview About the Public Libraries Act | ontario.ca

A strong library system is a cornerstone of a strong community. It contributes to education, literacy and life-long learning.

Section 2(b) of the Charter of Rights specifically addresses "freedom of thought, belief, opinion, and expression, including freedom of the press and other media of communication."

BY-LAW 2025 - 22

Being a By-law to establish a Site Plan Control Area within the limits of the Township of Essa (Site Plan Control Area By-law).

WHEREAS Section 41 (2) of the Planning Act, R.S.O 1991, c. P. 13, as amended provides that a municipality may, by by-law, establish a Site Plan Control Area.

WHEREAS the Official Plan of the Township of Essa establishes site plan control policies and outlines the areas to which these policies may apply;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESSA HEREBY ENACTS AS FOLLOWS:

- 1. That the entire Township of Essa planning area is hereby designated a site plan control area, save and except for the following:
 - a. All lands zoned and used solely for agricultural purposes
 - b. All residential developments on an existing parcel of land containing up to 10 residential units.
- 2. That notwithstanding the areas designated under Part 1 of this by-law, site plan control areas may be designated as deemed necessary by the Council of the Corporation of the Township of Essa in accordance with the provisions of the Official Plan.
- 3. That this By-law may be referred to as the "Site Plan Control Area By-law"
- 4. That the Site Plan Control Area By-law shall apply to all developments with up to 10 residential units where the development is proposed within 300 metres of a railway line, and within 120 metres of a shoreline, inland lake, wetland, or river or stream valley.
- 5. That By-law No. 2001-68 and any amendments made thereto are hereby repealed as of the date this by-law comes into force and effect.
- 6. THAT this By-law shall take effect as of the date of passing, subject to the provisions of the Planning Act, R.S.O. 1990, Chap. P.13 as amended.
