1.0 Background

To further support its Housing Supply Action Plan and other priorities, the Ministry of Municipal Affairs and Housing is consulting on proposed changes to the Provincial Policy Statement (PPS). Comments are requested prior to October 20, 2019 (EBR Registry Number #019-0279).

The current PPS, which came into effect April 30, 2014, provides overall policy direction on matters of provincial interest related to land use planning and development across Ontario. Where provincial plans are in effect (such as the Growth Plan for the Greater Golden Horseshoe and the Greenbelt Plan in Wellington), such plans:

- provide additional, and in some cases, more specific land use planning policies
- take precedence over the policies of the PPS in the event of a conflict

Where policies in the PPS do not overlap with policies in provincial plans, the policies of the PPS must be independently satisfied.

This report provides an overview of the key policy changes and responds briefly to questions posed by the province in the consultation documents.

2.0 Key Changes to the Provincial Policy Statement

Many of the proposed changes appear to have little impact on the County as they:

- 1. harmonize the PPS with the 2019 Growth Plan for the Greater Golden Horseshoe ("Growth Plan") which already applies to Wellington; or
- the Growth Plan policies are more specific/restrictive than the draft PPS.

In other respects, staff have identified the following key areas with the greatest impact on land use planning in Wellington County.

Agriculture

Current PPS policies allow for planning authorities to permit non-agricultural uses in prime agricultural areas subject to meeting specific criteria. Some examples of non-agricultural uses include manufacturing, automobile sales, golf courses, and campgrounds. The draft policies remove the criterion that the proposed use "complies with the minimum distance separation formulae" (MDS). Instead, impacts on surrounding agricultural operations and lands are to be "informed by provincial guidelines". This is more permissive when compared to language used elsewhere in the PPS, such as "in accordance with provincial guidelines". While the wording would allow for consideration of guidelines in addition to MDS, such as the "Guidelines on Permitted Uses in



Ontario's Prime Agricultural Areas" we have questions about what these changes mean for MDS implementation.

Mineral Aggregates

Changes to subsection 2.5.2.4 include additional policy direction that depth of extraction be addressed through processes under the Aggregate Resources Act. The intent of the new wording is unclear and we are concerned that it may be meant to remove the ability of municipalities to continue to use vertical zoning to regulate extraction below the water table.

For gravel pits outside of the Greenbelt area and subject to satisfactory long-term rehabilitation, draft policies allow consideration of extraction in provincially significant wetlands (applies to areas outside of the County), woodlands, valleylands, wildlife habitat, areas of natural and scientific interest; fish habitat; and habitat of endangered species and threatened species. The Growth Plan is more restrictive for some features, but overall, the more permissive draft policies would appear to allow interim negative impacts to features and areas in favour of potential long-term environmental benefits through rehabilitation.

Indigenous Consultation

New requirement for planning authorities to:

- engage with Indigenous communities and coordinate on land use planning matters; and
- engage with Indigenous communities and consider their interests when identifying, protecting and managing cultural heritage and archaeological resources.

Extension of Planning Horizon

The planning horizon is extended from 20 to 25 years. We do not know whether the province intends to address this change in the Growth Plan for the Greater Golden Horseshoe, which provides a growth forecast to 2041.

Housing

The province has changed housing policies and related terms in an effort to encourage a greater mix and supply of housing. For example, a new term "housing options" provides more specific policy direction about housing types. The draft policies increase the required supply of land for residential growth from ten years to twelve years. Municipalities are also given the option to maintain land with servicing capacity to provide a five-year supply of residential units (up from three). Overall, these changes appear to be positive, but we will continue to assess as more information becomes available.

Servicing Hierarchy and Private Communal Services

The draft PPS clarifies that the servicing hierarchy supports protecting the environment, human health and safety. With that in mind, upper-tier municipalities are required to work with lower-tier municipalities to assess long-term impacts of individual services on environmental health and character of rural settlement areas and the feasibility of full municipal services or private communal services. Policies specify that communal services are preferred for development of multiple residential units/lots where municipal services are not available, planned or feasible.

Land Use Compatibility

Stronger protection is provided for existing or planned major facilities (including industries, manufacturing uses, other facilities and infrastructure) from proposed sensitive lands uses (such as residences, day care centres, etc.).

We have reported on the PPS review at this time to ensure that County Council may consider these comments prior to the October 20, 2019 deadline. We will be attending an information session with the province September 9 and the Association of Municipalities of Ontario (AMO) is working on a response. Planning staff may augment this report if we become aware of new information of relevance to Wellington.

Dear Minister Yurek:

At the September 27, 2019 meeting of the Association of Municipalities of Ontario Board of Directors, a number of matters were raised regarding the implementation of Schedule 2, Conservation Authorities Act, Bill 108.

While we await the implementing regulations, we are keenly aware that transition will take some time. Sufficient time to transition is required. Some preparatory work for creating implementing Bill 108 such as memoranda of understanding for some services are in place. However, most municipal governments and conservation authorities are commencing 2020 budget decisions now, and will not be able to fully implement MOUs for all non-mandatory services in the next three months. We would advise that it is better to plan an implementation for the 2021 fiscal year, provided all regulations are in place in the first quarter of 2020.

Additionally, the activities that support the mandatory programs need to be articulated. Specifically, to what level of detail is field work, monitoring and the resulting documents required? Better defining the scope of activities to support mandatory programs is essential for two reasons.

First, different regions of the province will need different requirements to meet the mandatory programs in a meaningful way. We anticipate that there should be a grouping of expectations reflecting high growth areas (which need deeper level of detail), average growth areas (which would need less detailed effort), and low or no growth areas (which would need a minimum standard of effort).

Second, some conservation authorities will have capacity to meet the threshold of requirements set for their degree of growth and some may not. In the cases where capacity is lacking, a strategy needs to be developed that does not strain municipal financial capacity.

AMO would also like to see a more comprehensive conversation regarding nonmandatory activities. There are many perspectives on the value of CA activities that raise revenues and in turn lower the levy expectations and requirements. This range of options needs local discussion. Further some consideration to dispute resolution needs to be taken. It is feasible that some local municipal governments may not agree on these discretionary activities and these different views will have fiscal impacts if not resolved in an orderly manner.

Similar matters were raised regarding the Blue Box. Your ministry developed a Blue Box mediation process with a very able facilitator, David Lindsay. This process brought all parties together to successfully resolve implementation concerns. We request a similar approach here, a working group of municipal government representatives, Ministry staff and Conservation Authority staff at a table to iron out principles for implementation.

We look forward to working with you on this very important matter.

2020 Ontario Municipal Partnership Fund Allocations Announced

Today, the Ministry of Finance issued 2020 allocation notices from the Ontario Municipal Partnership Fund (OMPF). The total funding envelope to municipalities will decrease by \$5 million to \$500 million. These dollars are distributed to 389 municipalities across the province and provide unconditional operating support for local frontline services.

At the 2019 AMO Annual Conference, Premier Ford announced that there would be, "no changes to the structure" of the OMPF for 2020. The \$5 million reduction will come from the Transition and Stabilization Grant component in keeping with recent practice. Allocations to all other grant components remain as they were in 2019.

Letters to Heads of Council and Treasurers are being sent at this time. Allocation notices may also be viewed on the Ministry's <u>website</u>.

The Ontario Municipal Partnership Fund (OMPF) provides unconditional operating support from the Province to municipal governments. It uses an equalization approach to address challenges in rural and northern communities, with funding based on various community fiscal health indicators.





- (6) The costs that arise from programs and services enabled through the Memorandum of Understanding with the Severn Sound Environmental Association.




Funding to support the YMCA Simcoe/ Muskoka

At Committee of the Whole on September 24, Rob Armstrong, CEO of YMCA of Simcoe/Muskoka led a presentation to County Councillors about the new YMCA Regional Hub in Barrie, which will support other YMCA centres throughout Simcoe County. Working in partnership

with Youth Haven, the new YMCA will be home to Simcoe County's first standalone transitional housing unit for youth. In addition to the transitional housing component, the building will also include an expanded youth/senior centre, aquatic centre, YMCA Youth Services (addressing employment, life-skills, entrepreneurship, youth at risk), support for new Canadians through YMCA Immigrant Services, traditional health & fitness programming, community meeting spaces, and a public café.

This week, County Council voted to provide \$2.5 million donation capital funding to the Barrie YMCA across four years to be dedicated to Youth Haven Transitional housing and child care services, conditional on the HUB capital project proceeding.

Provincial Blue Box Special Advisor's Report and Minister's Blue Box Transition Direction


On May 14, Council received a Provincial Discussion Paper – Reducing Litter and Waste in our Communities, which described a number of key areas for provincial action including making producers responsible for their waste. Producer responsibility will reduce the collective financial burden on Ontario municipalities by approximately \$130 million annually. This is something that the County has been advocating for over the past several years.

Council received an update on the special advisor's report on the provincial blue box program transition. The provincial blue box program is on course to transition to producer responsibility through a phased approach between 2023 and 2025. The County's 2018 blue box program costs were \$7,137,916, partially offset by producer funding received in 2018 of \$3,140,984 for a net cost of \$3,996,932. Theoretically, upon transition to producer responsibility, this cost would be removed.



Paramedic Services Facility Plan Update

In 2007, further to Council direction, staff engaged with consultants to assist in the development of a Paramedic Services facility model. In September 2008, a new model was introduced, including a hybrid facility model of both station-based and hub/post Paramedic Services facilities. Paramedics report into hubs for duty, check their vehicles and equipment, restock supplies, and undertake other activities as needed. Once fully equipped, staff are directed to appropriate posts in the community to optimize coverage and response across the area. Posts are located in high demand areas within the larger geography to ensure timely coverage. They typically have a smaller footprint with one vehicle bay, washroom, kitchenette and computer workstation.




Council received an update to the Paramedic Services Facility Plan including the status of current facilities, ongoing projects and potential future implications over a 10-year planning horizon. Both the Barrie hub and Elmvale station projects are proceeding as per schedule. Hub occupancy is planned for 2020, and Elmvale station is planned for completion in the fall of 2019.

Update on County of Simcoe Official Plan Amendment No. 2 (ERRC)

Council received an overview of the status of the on-going land use approvals process, additional studies being undertaken and next steps in the development of the Environmental Resource Recovery Centre (ERRC), including the County's reforestation/restoration of 11 hectares of land at a 2:1 ratio to mitigate the environmental impacts of the ERRC, planting more than 21,000 trees.

The report included an update on the appeal proceedings, and noted that on August 29, 2019 the *Places to Grow Act, 2005* was modified in response to a number of specific planning matters, including County Official Plan Amendment No.2. This eliminates one issue and confirms the position previously taken by the Ministry and County.

Seniors Community Grant



On Thursday, October 17, Attorney General and local MPP, Doug Downey, held an event, hosted by the County at the Administration Centre in Midhurst, to announce funding under the Seniors Community Grant Program. The Ministry for Seniors and Accessibility is providing the County of Simcoe with more than \$13,000. This funding will support with the execution of Simcoe County Seniors Safety and Security Symposiums, as part of our Age-friendly Initiatives, on elder abuse, fraud and cyberscam awareness, fire safety and prevention and personal emergency preparedness.

Paramedic Services Response Time Performance



Prior to the downloading of land ambulance services to the upper tier municipalities there were no legislated response time standards in place. Now, the Ambulance Act mandates that response time performance targets for a given calendar year be reported to the Ministry of Health no later than October 31 of each year.

County Council received a report that confirmed 2018 response time performance targets were reached or exceeded. Review of mid-year 2019 performance suggests that response time targets will continue to be met. Council also learned how Paramedic Services across the Province continue to advocate for enhancing the accuracy in the prioritization of calls through improvement in dispatch practices to reduce response time performance for more urgent patients.

Trillium Gift of Life Network



Trillium Gift of Life Network (TGLN) is the Government of Ontario agency responsible for delivering and coordinating organ and tissue donation and transplantation services across the province. The TGLN is seeking to increase its number of tissue donor referrals by exploring alternative methods of receiving tissue donor referrals from its community-based partners. As Ontario Paramedics often attend 9-1-1 calls that result in pronouncement of death in the home, TGLN has begun partnering with Ontario Paramedic Services to assist in achieving their goal.

County Council voted to implement the Paramedic Service Community-based Death Referral Program in Simcoe County. The program will go live following the final continuing education session for our Paramedics in December 2019. Paramedics will collect next of kin information and call the TGLN, where co-ordinators receive the patient's personal health information provided by the Paramedics and screen the patient for donation eligibility.

Community 10-Year Affordable Housing and Homelessness Prevention Strategy Update

Under the Housing Services Act, 2011, Service Managers, including the County, are required to review their Affordable Housing and Homelessness Plans at least once every five years. Our Community 10-Year Affordable Housing and Homelessness Prevention Strategy was approved by Council in 2014. The 2019 update is in alignment with current provincial policy direction, confirms the continuing validity of

the original comprehensive strategy, and affirms the County's commitment to the vision of adequate, appropriate and affordable housing for Simcoe County residents.

Council received a report on the 2019 update, which highlights continued need for an increased supply of affordable housing in Simcoe County, particularly the need for rental housing. The target of 2,685 units by 2024 remains a minimum target towards meeting the needs across the County, and to-date since 2014, the County has created approximately 1,500 new units.



County Road 90 / County Road 27 - Speed Reduction Request

In establishing County speed limits, it is important that the posted speed limit meet with driver expectations. Studies show that speed limits should be set to reflect a speed the majority of drivers consider safe and reasonable under favourable conditions. To determine

appropriate speed limits along County roadways, the Transportation and Engineering Department uses the Transportation Association of Canada's Canadian (TAC) manual. Many risk factors are taken into account, including lane width, pedestrian and cyclist exposure, and number of private access driveways.

In response to concerns regarding the school bus stops along a section of County Road 90, a speed survey was undertaken on this section of the road from May 6 to May 10, 2019. Approximately 76,000 vehicles surveyed. Based on this information, Council voted that a speed limit of 60 km/h on County Road 90 / Mill St from Tumbull easterly to Don Ross Drive be implemented and that the limits of the 50 km/h speed zone on County Road 27 be extended further north of Thornton to the Thornton Cemetery.

Greetings,

The Ministry of Natural Resources and Forestry (MNRF) is proposing legislative changes to seven statutes and to make a new regulation under the *Lakes and Rivers Improvement Act*. The legislative changes are part of the proposed *Better for People, Smarter for Business Act, 2019*. If passed, these changes are intended to support the government's commitment to reduce unnecessary red tape and regulatory burden and modernize government to be simpler, faster and more cost-effective, while ensuring the sustainable use of natural resources and public health and safety are not compromised.

A proposal to amend the following three Acts and propose a new regulation is posted on the Environmental Registry.

- 1. Crown Forest Sustainability Act, 1994
- 2. Oil, Gas and Salt Resources Act
- 3. Lakes and Rivers Improvement Act and new Minister's regulation under the Act

The proposed amendments and new regulation are described below:

- Proposed amendments to the Crown Forest Sustainability Act, 1994, would if passed:
 - Enable the issuance of a "permit" to allow a person to remove forest resources from a Crown forest for non-forestry purposes.
 - Modernize the requirements for annual work schedules by removing the requirement for MNRF approval.
 - o Enable the Minister to extend a Forest Management Plan.
- Proposed amendments to the Oil, Gas and Salt Resources Act, would if passed:
 - Allow future regulations to be made, where appropriate, to relieve existing activities from requirements that would apply to new activities.
 - Enable the use of a rules-in-regulation approach, or the mandatory issuance of approvals for more activities, subject to conditions and requirements that would be set out in regulation intended to streamline approvals for the specified activities.
 - Clarify the types of geological evaluation and testing activities captured by the definition of "well".
- Proposed amendments to the Lakes and Rivers Improvement Act, would if passed:
 - Create a new Minister's regulation-making authority in the Lakes and Rivers Improvement Act to allow the Minister to require some owners of electricityproducing dams to, where necessary, assess, monitor and report on methyl mercury related impacts to water and fish.
 - Amend an existing authority to incorporate guidelines by reference in the regulations.

Regulation Proposal

o If the proposed Lakes and Rivers Improvement Act legislative amendment is passed, the ministry proposes to develop a subsequent Minister's regulation that if made, would require some dam owners of electricity-producing dams to, where necessary, assess, monitor and report on mercury levels in surface water and/or fish tissue. We are also seeking comments on this proposed regulation via this notice. Owners of the twelve existing dams that currently have mercury assessment, monitoring and reporting requirements established through Ministry of Environment, Conservation and Parks issued Permits to Take Water, would, if the regulation is made, continue these requirements under the authority of the Lakes and Rivers Improvement Act and reporting would be to the Ministry of Natural Resources and Forestry. Each of these twelve Permits to Take Water were subject to consultation prior to their issuance.

New or significantly redeveloped electricity-producing dams may, if the regulation is made, require assessment, monitoring and reporting of mercury, where there is a new or expanded head pond area and/or where there are identified risks associated with human consumption of fish.

The Ministry of Environment, Conservation and Parks is concurrently consulting on a proposal to amend the Ontario Water Resources Act Permit to Take Water requirements for electricity-producing facilities. In addition, there are other administrative and housekeeping changes proposed for the Crown Forest Sustainability Act, 1994 and the Oil, Gas and Salt Resources Act.

SOUNDING THE ALARM ON THE SILENT KILLER

UTOPIA, ON — You can't see it, taste it, smell it, or touch it. The only way you have of knowing that Carbon Monoxide is lurking, is with a working CO alarm.

"Many people don't even recognize the sources of carbon monoxide that are in their homes," says Essa Fire Chief Cynthia Ross Tustin. "It could be the car in your attached garage, your gas fired hot water heater; or your oil furnace. Even your wood stove, these are all potential sources of carbon monoxide. And unless you have a working CO alarm, you'll never know until it's too late." Small children and the elderly are particularly susceptible to the poisonous gas.

There have been many incidents right here in Essa where carbon monoxide alarms have saved lives; they were properly installed as required outside sleeping areas in homes. The Essa Fire Department reminds everyone to ensure their alarms are working; but we are going one step farther. We encourage all building owners with fuel burning appliances to install CO alarms for the safety of their customers and employees.

Across Ontario, "Carbon Monoxide Awareness Week" is November 1st to 7th each year. Carbon monoxide (CO) is the leading cause of accidental poisoning deaths in Ontario, in Canada, and across North America. The Essa Fire Department promotes having a working CO alarm all year; but since November is the start of prime heating season, we are additionally reminding people to have their fuel burning appliances inspected and their chimneys cleaned.

CO is produced by the incomplete burning of fuels and can be released by fuel burning appliances, cars, barbeques and generators. Residents are encouraged to contact the fire department if they are unsure if they require one or more carbon monoxide alarms in their home; and are reminded to check their devices to see if they have expired; and to test their devices monthly.

Opportunities for Municipal Action on the Opioid Crisis

Prepared by the Steering Committee of the Simcoe Muskoka Opioid Strategy (SMOS), October 2019

SMOS is a cross-sector partnership of agencies and individuols addressing the opioid crisis in Simcoe and Muskoka

Through 2018 and 2019 to date, awareness of the impacts of the opioid crisis amongst communities in Simcoe and Muskoka has grown considerably. Several municipal councils have expressed interest in taking action to help address this urgent situation. As a support to municipalities, the steering committee of SMOS has developed this document of suggested opportunities for action within the realm of municipal jurisdiction. These ideas are relevant to Simcoe and Muskoka broadly speaking, but should be tailored to the needs of each municipality as some items may be more relevant than others, and additional items may be important. Local information and partnership may be available through the following collaborative opioid/drug strategy working groups in Simcoe Muskoka, connected to the work of SMOS:

ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF ENBRIDGE GAS INC.

Enbridge Gas Inc. has applied to raise its natural gas rates effective January 1, 2020

Enbridge Gas Inc. has applied to the Ontario Energy Board for approval to raise its natural gas rates effective January 1, 2020, based on a rate-setting framework and other adjustments previously approved by the Ontario Energy Board for the period 2019-2023. The rates are set using a formula that is tied to inflation and other factors intended to promote efficiency. If the request is approved, a typical residential customer in the EGD Rate Zone and in the Union Rate Zones (former customers of Enbridge Gas Distribution Inc. and Union Gas Limited, respectively) would see the following increases:

| Rate Zones | Residential Annual Bill Increase |
|------------------|----------------------------------|
| EGD | \$7.53 |
| Union South | \$4.26 |
| Union North East | \$5.07 |
| Union North West | \$5.80 |

Enbridge Gas Inc. has also applied to recover capital expenditures related to two projects that are not part of Enbridge Gas Inc.'s regular capital expenditure plan. Enbridge Gas Inc. states that if this request is approved, it will increase the above-noted bill impact in the EGD Rate Zone by an additional \$0.40 per year and the above-noted bill impact in the Union South Rate Zone by an additional \$1.49 per year.

Enbridge Gas Inc. also states that in November 2019 it will file a cost allocation study for the Union Rate Zones, including a proposal to address TransCanada's C1 Dawn to Dawn TCPL service.

Other customers may also be affected. It is important to review the application carefully to determine whether you will be affected by the changes.

THE ONTARIO ENERGY BOARD IS ALSO HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas Inc. We will question Enbridge Gas Inc. on the case. We will also hear questions and arguments from individual customers and from groups that represent the customers of Enbridge Gas Inc. At the end of this hearing, the OEB will decide whether the rate increase requested in the application will be approved.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Enbridge Gas Inc. on the OEB's wobsite now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by November 11, 2019 or the hearing
 will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

2019 Third Quarter Budget Report

On March 22, 2019 the Board approved the NVCA's 2019 budget. Quarterly reports are given to the Board to update on the status of the budget activities and any variations expected.

The following are the highlights for the first 9 months of operations of the NVCA:

- Expenditures to date are on track, with 69.40% of the budgeted expenses (75% of budget year completed).
- Revenues are tracking well, with 78.59% of the budgeted revenues recognized.
 This includes the first nine months of the general municipal levy of \$1,814,057.
- Program areas at this time, are tracking revenues and expenditures consistent with the approved budget and a balanced budget is anticipated.

Sharing mapping data with Greenland International Consulting

Chris Hibberd, NVCA's Director of Watershed Management Services provided a verbal update to the Board of Directors regarding sharing hydrology modelling data with Greenland International Consulting for research and development purposes.

A data sharing agreement is being drafted to ensure the share hydrology modelling data is only used for the purpose of research and development.

Once the draft is completed, staff will share the agreement with the Board of Directors for revision and review.

Meeting with Ministry of Environment, Conservation and Parks.

On October 28, NVCA will be meeting with the Minister of Environment, Conservation and Parks (MECP), as part of the pre-consultation meetings that MECP is holding with all 36 conservation authorities. The pre-consulting meetings are for an opportunity to outline the delineation between mandatory and non-mandatory services and activities, how these are currently funded, and their connections and benefits to local municipalities' priorities and the Made-in-Ontario Environmental Plan
