O. Reg. 343/22: Firefighter Certification

Dear Heads of Council and Chief Administrative Officers,

I am writing to provide an update on the work that we have been doing on firefighter certification under the *Fire Protection and Prevention Act, 1997*.

I am pleased to let you know that O. Reg. 343/22: Firefighter Certification has been filed under the Act. It is available on e-Laws <u>here</u>.

Throughout the consultation period, we received tremendous feedback and support from municipalities, fire chiefs, and partner associations including the Ontario Association of Fire Chiefs, Ontario Professional Fire Fighters Association and the Fire Fighters Association of Ontario. The Office of the Fire Marshal (OFM) has been working collaboratively with all partners to understand the regulation and how the OFM can best support departments at the local level throughout the implementation period.

The final regulation reflects changes related to exceptions, transition, and certification standards in response to feedback received during the Regulatory Registry posting period and during the municipal technical briefings. This feedback assisted in finalizing the firefighter certification regulation, which provides flexibility for local municipalities, while supporting firefighter and public safety.

With this regulation, we are not asking that firefighters train to higher levels than they already are. Certification is a process of verification, ensuring that a firefighter is trained to the standard they are required to perform, as set out in the level of service determined by a municipal council or territory without municipal organization.

Mandatory certification in Ontario will validate the training that firefighters receive and, in turn, will create safer communities.

Many of the comments received with respect to implementation have also been or will be addressed in the coming months. For instance, to address capacity pressures within the OFM, we are already increasing the staff complement for both the Ontario Fire College (OFC) and our Academic Standards and Evaluation Unit. This will ensure that we can respond to the current and ongoing demand for training and certification across Ontario.

We also continue to refine and enhance both our Adjunct Instructor and Regional Training Centre models to meet provincial demand. Learning Contract accessibility has been expanded allowing fire departments that already train together to continue to do so in order to achieve certification. The OFC will also be working with fire departments to increase their own internal training capacity and will be exploring opportunities to provide additional training for senior officers through upcoming seminars, conferences and webinars.

At the same time, we heard from many departments that purchasing textbooks and other training essentials is challenging. We have therefore explored options with the Fire Marshal's Public Fire Safety Council (FMPFSC) to look at supports that they can provide on the procurement of textbooks and other materials. The FMPFSC is supportive of the certification file and will be finalizing options that will be communicated to fire departments shortly.

I am pleased that we have been able to work so collaboratively with municipalities, fire departments, and other partners to have this regulation finalized. With a long implementation window, we are confident that certification is achievable and look forward to working with firefighters across Ontario as this regulation is operationalized.

Investments take root

County continues to support reforestation efforts

Midhurst/April 25, 2022 – Spring is a time of renewal, rebirth and rejuvenation. It is also the ideal time to plant trees across our region. As we celebrate 100 years of the Simcoe County Forest, the County remains committed to maintaining, protecting, and growing our Simcoe County Forest, while also encouraging private landowners in their reforestation efforts.

Driven by the commitment of County Council and our forestry program, in 2007, the County established the Simcoe County Tree Program, which directly funds the planting of trees in Simcoe County. The program provides local organizations including the Nottawasaga Valley Conservation Authority, Lake Simcoe Region Conservation Authority, Severn Sound Environmental Association, and Dufferin Simcoe Land Stewardship Network, with vital funds to support tree planting initiatives across the region. Over the past 15 years, the County's investment, combined with contributions from other organizations and landowners, has culminated in more than 853,000 trees being planted on 530 hectares of land.

In 2022, an additional \$30,000 has been committed to continue with these important efforts. These funds are supporting upcoming sustainability efforts, including volunteer tree plantings at the following locations in late April and early May:

- Township of Adjala-Tosorontio facilitated by Dufferin Simcoe Land Stewardship Network
- Township of Oro-Medonte facilitated by Severn Sound Environmental Association in partnership with Scouts Canada
- Township of Springwater Coughlin Tract facilitated by the Simcoe County Forest

As part of the 100th Anniversary of the Simcoe County Forest, the County will be supporting our partner organizations with plantings through the spring and fall seasons. For details on this program visit <u>findyourforest.simcoe.ca</u>.

"Simcoe County is proud of our nationally leading forest management practices, which has enabled us to continue to operate and grow the largest municipally-owned forest network in Ontario," said Warden George Cornell. We also continue to invest in programs that support our partners with their efforts to expand reforestation initiatives on private lands, helping to maintain the health of our forests and greenspaces for future generations."

County identifies efficiencies and modernization to regional library structure

Midhurst/April 26, 2022 – In 2019, the Government of Ontario initiated the Regional Government Review (RGR), an exercise to identify efficiencies in municipal service delivery and governance across the Province. The County of Simcoe struck the RGR Task Force and moved items to the Governance Committee to review and provide recommendations.

While numerous services have been considered by County Council, Councillors agreed that there were opportunities to streamline service delivery options for residents by modernizing supports currently provided through the Simcoe County Library Co-operative, which is managed by the County of Simcoe. As a result, after consultation with the local libraries and recommendations from an external consultant, County Council approved moving to a new Information Library Service (ILS) structure.

Under the ILS, taxpayers will see annual savings of \$295,000 moving forward.

There will be no downloading to the local libraries, and benefits to the local library branches include:

- Upgraded, cloud-based e-services IT platform
- Upgraded library computers software to Microsoft365 (which will allow for greater IT support and security)
- Speed and direct control over technical challenges by library CEOs through immediate resolution with IT HelpDesk and vendor
- State-of-the-art government grade cyber security threat protection
- Single electronic library card, opening resources for all patrons regardless of municipality supported through reciprocal borrowing agreements
- Continued support with regional procurement efforts
- Elimination of over \$50,000 in licencing fees paid by municipal library branches to the County
- Existing collections of materials owned by the County of Simcoe will be donated to library branches for public access at no cost to the individual municipal branches; this includes multilingual collections

It is important to note that the Library Co-operative does not provide library services directly to the public (it is not a public facing branch). Rather, it provides supplemental services to member municipal library branches through a largely administrative role, including circulation of videos and books, and helps to oversee the licensing process and functionality of some library software.

It is also important to note that the Library Co-operative was the last remaining Library Co-op in Ontario. Upon review, the circulation support was a duplication of services, as the Ontario Library Service provides the same circulation functionality to participating libraries across Ontario. Library branches may choose to utilize savings as they deem appropriate through the reduction of software licencing costs under the new ILS structure as the County will absorb these licensing costs moving forward.

Residents want to see responsible, efficient, innovative and modern service structures from their governments. The new ILS structure will provide benefits to residents, the County and our local library branches at a reduced cost.

County Council also endorsed a motion to proceed with an investigation into the sharing of confidential information prior to it being discussed at County Council. Furthermore, County Council approved a motion to request that the Province modify the Public Libraries Act to provide greater accountability by libraries to municipalities and taxpayers.

We deeply value the vital role that libraries play in our communities, and collectively look forward to modernizing and enhancing the way our residents access and benefit from library services moving forward.

2021 Financial Statement

NVCA receives clean audit for 2021.

Board members received the 2021 NVCA audited financial statements as presented by KPMG LLP Chartered Accountants. The financial statement is <u>available on NVCA's website</u>.

Employee Handbook Update

The Board of Directors approved the updates to the Employee Handbook. The updates included three changes to the employee handbook all around OMERS and benefits for all nonpermanent full-time employees.

2022 First Quarter Budget Report

In the first threes months of operations of NVCA, expenditures to date are tracking behind schedule, with 16.25% of the budgeted expenses (25% of budget year completed), partially because expenses are usually low for the first few months of the year.

Revenues are tracking well, with 21.52% of the budgeted revenues recognized. This includes the first 3 months of the general municipal levy of \$651,192.

Currently, NVCA is sitting in a surplus position, primarily due to two reasons:

- 1. Revenues are tracking higher than expenses currently
- 2. There was a large payroll accrual in 2021 due to the timing of the last payroll and a larger than normal vacation accrual which when reversed in 2022, causes our payroll expenses to show lower than normal but will be caught up as the year moves forward.

Motion to amend scheduled board meetings

The Board of Directors defeated a motion to amend the current eleven regularly scheduled meetings to seven regularly scheduled meetings.

Re: New Home Tax Rebate Program

At the regular Council meeting held on April 19, 2022, the Council for the Corporation of the Town of South Bruce Peninsula discussed the New Home Tax Rebate Program. Our Council is focused on increasing the instances where both attainable and affordable housing are available to more residents of not only South Bruce Peninsula, but all across Canada. Council is pleased that the New Home Tax Rebate Program exists, and they applaud the government's commitment to assisting new home buyers.

Council, in their review of the program, respectfully requests that the Federal Government reconsiders their portion of the program. Council is encouraged by the Province of Ontario's program and would like to see the Federal Government either mirror the rebate program implemented by the Province of Ontario, or alternatively, increase the purchasing threshold to an amount which is greater than the current \$450,000 ceiling. In today's housing market, the instances of new houses being purchased for anything under \$450,000 is extremely rare, making the receipt of Federal rebate money not possible for most new home buyers.

Council adopted resolution R-144-2022 which is attached to this correspondence. We look forward to your consideration of this important issue and receiving a response with regard to same.

Excerpt from Council Meeting Minutes – April 19, 2022

28. Notice of Motion – Mayor Jackson, New Home Tax Rebate Program

Discussion included the purchasing of homes and the government programs.

R-144-2022

It was Moved by J. Jackson, Seconded by K. Durst and Carried

Whereas attainable housing has been a concern for residents across Canada;

And whereas attainable housing is a priority for all levels of government;

And whereas the Government of Canada and the Province of Ontario have implemented HST and GST rebate programs for those purchasing newly constructed and majorly renovated homes;

And whereas the Province of Ontario rebate program applies to the first \$400,000 of the purchase price of the new home and land, as the case may be, with a maximum rebate of \$24,000;

And whereas the Government of Canada rebate program applies only to new home and land purchases, as the case may be, under \$450,000, with an incremental decrease in rebate as the purchase price reaches \$450,000 and the maximum rebate being \$6,000;

And whereas the cost of new home construction has risen exponentially such that the majority of Canadians cannot afford to purchase a newly constructed home;

And whereas the Province of Ontario rebate program goes a long way toward assisting Ontarians purchase newly constructed homes.

Now therefore be it resolved that the Corporation of the Town of South Bruce Peninsula requests that the Government of Canada reviews its rebate program and considers implementing their rebate program in the same manner as that of Ontario meaning that there is no incremental decrease applied to the rebate and instead a maximum rebate is established for new home purchases under \$450,000;

And that alternatively, if the Government of Canada does not see fit to mirror the rebate program of the Province of Ontario, that the Government of Canada increases its new home purchasing threshold to an amount significantly higher than \$450,000 which is reflective of today's housing market;



And further that Council's position on this matter is circulated to Prime Minister Justin Trudeau, Premier Doug Ford, MP Alex Ruff, MPP Bill Walker and all municipalities in Ontario.

- 2. Hosting a litter cleanup on Tuesday, May 10 or on the weekends surrounding the Day of Action, for the public or your volunteers or employees to participate in.
- 3. Sharing and promoting use of the <u>Litter Cleanup Guides</u> and <u>Litter Cleanup</u> <u>Reporting Form</u>.
 - Our Litter Cleanup Guides include information on organizing a safe, successful litter cleanup and a form for participants to track what they collect during their cleanup.

Our cleanup guides webpage now includes a new guide for educators and schools, to help engage students and youth in litter reduction and prevention efforts.

Please note the cleanup guides notify participants of potential municipal requirements, such as: confirming whether a permit is required to cleanup a certain area or seeking a litter disposal method.
